

**ORDER NUNC PRO TUNC ON
 JUDGMENT AND ORDER ON REMAND APPROVING ATTORNEYS' FEES
 AND CLASS REPRESENTATIVES' CASE CONTRIBUTION AWARD**

WHEREAS, the Court has been made aware of certain scrivener's errors on pages 48, 49 and 50 of the Court's Judgment and Order on Remand Approving Attorneys' Fees and Class Representatives' Case Contribution Award entered August 17, 2021, filed August 18, 2021 (the "Fee Judgment") resulting from Class Counsel having omitted the original \$400,000 Class Representative Award from certain of the calculations of the Fee Trust, and thus resulting in an erroneous allocation of the interest earned on the Fee Trust;

THEREFORE, the Court hereby corrects and modifies the Fee Judgment as follows:

Correction 1: Page 48, Paragraph 119, Findings of Fact – Fee Trust, by deleting \$25,336,866.29 and replacing it with \$25,736,866.29;

Correction 2: Page 49, Paragraph 120, Conclusions of Law – Fee Trust, by deleting \$7,289,922.86 and replacing it with \$7,689,922.86;

Correction 3: Page 49, Paragraph 121, Conclusions of Law – Fee Trust, by deleting the table and replacing it with the following table:


Correction 4: Page 50, the first adjudication, by deleting the table and replacing it with the following table:
